Agripreneurship Orientation Program

Agripreneurship orientation program is aimed at providing an opportunity to students/youth to work on their innovative ideas by imparting two months training cum hands on internship with other startups. Guided by experienced and innovative startups, they will be able to understand business concepts/nuances, strategy and practical insights of specific industries or markets, challenges and strategies to resolve them.

Opportunity to youth, students, smart farmers, women or anyone having an innovative idea and want to start an agri-business venture are encouraged to apply. The program will provide two months training, grant in aid as 90 percent grant up to a maximum of Rs. 5/- lakhs through R-ABIs to convert their idea/proof of concept into prototype/ product to selected entrepreneurs.

Objectives

- To nurture potential Agripreneurs by providing training cum internship with other startups to provide them practical, technical and business insights.
- To create and nurture a pipeline of Agripreneurs for incubators.
- To make pursuing entrepreneurship related to innovative ideas an attractive career option among other available career choices.

With respect to above, a call for application is invited from eligible Agripreneurs having an innovative idea in technological solutions/processes/products/services/business platforms etc. and wants to start an agri-business venture for Pre-Seed Stage Funding as Grant in aid to Agripreneurs under RKVY-RAFTAAR scheme at KRISHIK -R-ABI, UAS, Dharwad.

Eligibility Criteria:

- The applicant should be an Indian citizen
- All incubatees of KRISHIK-R-ABI will be eligible for this funding after completion of two months training on the basis of consistent performance evaluated by KRISHIK-R-ABI Incubation Committee (CIC)
- A startup once supported by any other R-ABI will not be eligible to apply for KRISHIK for subsequent round of pre-seed and seed support.

Selection process and funding support:

- a. The selection of Agripreneurs will be based on innovative solutions/processes/products/services/business models in agriculture and allied sector shall be done by KRISHIK-R-ABI Incubation Committee (CIC).
- b. During the selection process KRISHIK-R-ABI will take into consideration any other grant-in-aid funding received by incubatee for the same activity/product from other GOI ministries. A self-declaration from the incubatee about such funding will be mandatory.
- c. After two months of training of incubatees, CIC will evaluate the progress of the incubatee and based on their performance recommend them for pre-seed stage funding to RC
- d. RC will further evaluate and recommend the incubatees to the nodal division *Department of Agriculture, Cooperation & Farmers Welfare (DAC&FW)* for pre-seed stage funding.
- e. Nodal division, DAC&FW will approve and sanction the project of the incubatees based on recommendation of RC and release the first instalment of the grant-in-aid to KRISHIK-R-ABI Incubation Committee (CIC) for further disbursement to the incubatee.
- f. The KRISHIK-R-ABI would execute a legal agreement with the incubatee who is selected for the seed support and this agreement should be signed before the release of the first instalment of pre-seed fund to the incubatee. The terms of agreement with incubatee should be framed by the KRISHIK-R-ABI linking with the progress milestone, monitoring norms etc. Subsequent disbursement schedules should be linked to the achievement of milestones by the incubatee.
